### FROM THE POOL TRUSTEE

We have had some major milestones this year for our pool. The pool was replastered for only the second time since it has been here—wow what an improvement! And, the safety of our pool was upgraded by the addition of dual main drains.

For next year, we are looking for a Country Club member to **run for the position of Pool Trustee, and to hire a pool operator for the summer**. I performed both the Pool Trustee and Pool Operator positions this year. They are two distinct jobs and have different responsibilities. Becoming the Pool Trustee is not as time consuming as most people would think, and the position of Pool Operator will be a **paid position** next year. I am always happy to help, and will be available for backup. The position of Pool Trustee should have a two-year turnover, so more people can know the workings of the pool. Below are descriptions for both positions.

#### The duties of the Pool Trustee are:

- Attend monthly board meetings
- Hire Pool Operator, and supervise their job
- Coordinate pool repairs in conjunction with pool operator
- Coordinate with Assistant Pool Trustee (on swim lessons and lifeguards as needed)
- Coordinate winter maintenance of the pool
- The Pool Trustee should be willing to learn general knowledge about the pool, and how it works.

**Benefit: Pool Trustees membership fees are waived.**

#### Pool Operator Position

The Pool Operator position is the job for the daily maintenance of the pool.

#### Daily opening of the pool:

- Removing the cover
- Safety check
- Daily pool chemical check
- Record daily chemicals levels
- Adding chemicals as needed—(calculating amount needed, correct handling of chemicals)
- Vacuumping pool

#### Weekly and Monthly maintenance of the Pool:

- Inventory and stocking pool chemicals

#### Weekly chemical checks:

- Backwashing/maintenance of filters
- Checking all equipment, troubleshoot when possible, coordinating with Pool Trustee on broken equipment

#### Weekly winter maintenance of the pool:

## **BUILDING TRUSTEE BOARD POSITION OPEN**
