POOL IMPROVEMENTS FOR SPRING 2010

In our last newsletter, I mentioned the Virginia Graeme Baker Pool and Spa Safety Act, which requires updates to our main drains in both the swimming pool and wading pool. The best way to meet the requirements is to install dual main drains on both pools. This necessitates digging up the bottom of the pools and reconfiguring the drains. When this work is complete, we will then have both pools re-plastered. This will make both pools look practically brand new. I am working on receiving bids from 3 to 4 companies to perform the work this spring. The members of the Board and Pool Committee will review the proposals, and make a recommendation to all of you, the owners of the pool, as to what company we should use. It will then be up to all of us owners to vote to allow the Board to spend the money for these upgrades. The cost will run close to \$30,000. The good news is that we have funds available for most of this work, so we are trying to work within our budget so we won't have to do a special assessment to cover the work.
