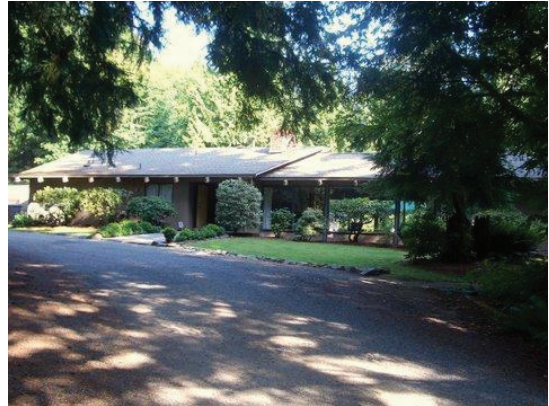
## REMEMBER TO PAY YOUR DUES!
